Subject:- Safeguard investigation concerning imports of Nylon Tyre Cord Fabric (NTCF) ; Termination of Investigation order :

G S R D-22011/45/08 dated April, 6th 2009 having regard to the Customs Tariff Act, 1975 and the Customs Tariff (Transitional Product Specific Safeguard Duty) Rules, 2002 thereof;

1. PROCEDURE

- i) The Notice of Initiation of Safeguard investigation concerning imports of Nylon Tyre Cord Fabric (NTCF) into India from the People's Republic of China was issued on 6th February, 2009 and was published in the Gazette of India Extraordinary on dated 6th February, 2009. 2. FACTS

The applicants have requested for withdrawal of the application with request to terminate the present investigation, with a liberty to the domestic industry to re-apply for imposition of Safeguard Duty in case the situation so arise.

3. ORDER

The request of the applicants was considered, and the investigation was found to have become infructuous upon request for withdrawal of the application.

Accordingly the Safeguard Investigation initiated under Rule 6 of the Customs Tariff (Transitional Product Safeguard Duty) Rules, 2002 on 6th February, 2009 vide GSR 79 (E) dated 6th February, 2009 concerning imports of Nylon Tyre Cord Fabric (NTCF) into India from the People's Republic of China is hereby terminated.
